# GENERAL TERMS AND CONDITIONS OF CONTRACT FOR THE SUBSCRIPTION TO THE ALMALAUREA OF

- **Art. 1 Object of the contract.** These general terms and conditions regulate the subscription to the databank of AlmaLaurea.
- **Art. 2 Publication of data.** Data contained in the AlmaLaurea databank are published three times a year, in particular at the beginning of March (1st graduation session) for those who graduated between September and December of the previous year; at the beginning of July (2nd graduation session) for those who graduated between January and April of the current year and at the beginning of November (3rd graduation session) for those who graduated between May and July of the current year.
- Art. 3 Graduands and newly graduated students to be inserted in the graduates'databank. Both graduands'curricula and though for a short time- the curricula of newly graduated students can be found in the section "Graduands and newly graduated students to be inserted in the graduates' databank". Since they aren't yet officially recognized as "graduates", the content of the CVs has not been checked yet by universities, nor has it been checked by AlmaLaurea. Therefore, they just contain self-evaluations made by the students themselves.
- **Art. 4.-** *Credits for curricula.* Each kind of subscription to the databank of AlmaLaurea is associated to a total amount of credits, that is the maximum number of curricula that can be downloaded by the user within the period of validity of the subscription. In case of renewal of the contract, the number of credits left from the previous contract will not be available anymore for the download of curricula. The user has an unlimited number of searches to carry out through the online databank of AlmaLaurea. For privacy reasons, all curricula will be displayed without graduates' personal data. In order to display the complete version of the curricula, including graduates' personal data, the user may download them by using the download function in the databank. This implies a proportional decrease in the number of credits available.
- **Art. 5 MyAlmaLaurea's services.** The services of MyAlmaLaurea, which can be used by the contractor as long as the subscription is active, are the following ones:
  - 1. Processing and making changes in the personal profile;
  - 2. Each search of candidates can be saved and users have the opportunity to reactivate or modify them at any time;
  - 3. All curricula downloaded from the databank can be saved online in the user's personal area. Each user has the opportunity to access the most recent version of curricula at any time, without having the credits decreased.
  - 4. Check of duplicate curricula

Each download of curricula is checked by the system, which controls if the curricula had already been downloaded. If that is the case, the total number of credits assigned to the user will not be decreased.

- **Art.** 6 **Subscription credits recharge.** If the user has used up the credits available for curricula before the expiry date of the subscription, a credits recharge can be requested and will be then available. This service consists in the purchase of a given number of curricula for the unit price related to the kind of subscription made.

In case the contact person for the use of the databank is not the same person who is responsible for the purchase, the latter shall undertake to inform the contact person for the use of the databank on these terms and conditions of contract. The access code must not be given to third parties. The contractor undertakes to use the access code with the outmost carefulness, to ensure that it is not used by unauthorised persons. The contractor undertakes to report immediately the theft or loss of the access code, or of the material in which this code had been registered, by writing to AlmaLaurea.
